HUMANITARIAN AWARD

MELISSA SNYDER RICHARDSON, D.O., FACOS, MBA

Dr. Melissa S. Richardson, of Okemos, Michigan, has been selected to receive the ACOS Humanitarian Award that recognizes members' outstanding service to their community or state, the nation, and/or the international community. She was raised in northern New Jersey as the youngest of three daughters. Throughout her childhood, parents Bill and Judy Snyder modeled a strong Christian faith and a tireless work ethic. Melissa excelled academically and in multiple high school sports leading to a New Jersey State Championship in field hockey and a Division I college basketball scholarship at Manhattan College. During medical school, at the Philadelphia College of Osteopathic Medicine, she was the first woman to complete a combined D.O./MBA program in conjunction with St. Joseph's University in 1989.



She completed her Internship and General Surgical Residency through Michigan State University at Botsford Hospital in Farmington Hills, Michigan. Certified in General Surgery in 2000, she became a Fellow of the ACOS in 2008. Dr. Richardson's expertise and practice focus is minimally invasive surgical procedures but also includes the full spectrum of General Surgery and trauma care. She has spent her entire career living in, and serving the Lansing, Michigan community. Dr. Richardson is employed within the McLaren Health System and has held many leadership roles including serving as a board member with both Mid Michigan Physicians and the McLaren Medical Group. Currently she serves as Chairman of the Department of Surgical Services at McLaren Greater Lansing.

Dr. Richardson's experiences in mission service began early in her resident training when she was provided the opportunity to travel into Mexico along with her church, providing surgical care as well as mobile medical clinics. This early exposure, and her Christian faith, fueled a great desire to continue mission work as a significant portion of her career. She has been traveling to the Northwest region of Haiti since 2014 providing surgical missions encompassing General, Urologic, and Reconstructive surgeries. Along with a diverse team of physicians and nurses, Dr. Richardson has been able to perform multiple otherwise unavailable surgeries within these resource poor communities. Working with the local Haitian medical staff, multiple patients were cared for and treated for diverse non surgical conditions including cancer, abdominal tuberculosis, and many other chronic medical conditions. Her mission team has provided financial, educational, and spiritual support to the facilities and people of Northwest Haiti. She has found the Haitian people to be joyful and grateful and feels these relationships have changed her life, and her family's lives, forever. Dr. Richardson feels so blessed to be able to share her skills, time, and faith with the Haitian community. She looks forward to many future mission trips to Haiti and beyond as the Director of Surgery for World Health Partnerships, a non profit she has helped establish. Her mission team includes her husband Dan, who is a D.O. Emergency Physician, and their 19 year old twins, Jacob and Grace.

The American College of Osteopathic Surgeons is pleased to present the Guy D. Beaumont Jr. ACOS Award of Academic Excellence to Constance P. Cashen D.O., FACOS, FACS for her outstanding organizational leadership and excellence in improving the quality of Osteopathic education.



Dr. Cashen graduated from Michigan State University College of Osteopathic Medicine in 1979. She completed her internship and surgical residency at Art Center Hospital/Michigan Osteopathic Medical Center in Detroit Michigan in 1984 under the guidance of Randolph G. Roulier D.O., FACOS and William G. Anderson D.O., FACOS.

As a resident, Dr. Cashen was heavily involved in residency curriculum development. On graduating she developed her surgical practice at Parkview Hospital in Toledo, Ohio. This expanded to Mercy St. Vincent Medical Center and in 2006 she opened the Osteopathic Surgery residency, receiving mentorship from surgery program directors in the OUCOM OPTI: Alison Cleary D.O., FACOS, Roger Classen D.O., FACOS, Allan Meshekow D.O., FACOS, and John Galante D.O., FACOS. Her graduates have gone on to successful practices, many taking on active leadership and educational roles.

A strong advocate of Osteopathic philosophy, Dr. Cashen worked on the AOA Bureau of Education and co-authored the chapter on Surgery for the Foundations of Osteopathic Medicine textbook, now in its fourth edition. She is currently a member of the ACGME's Osteopathic Recognition Appeals Board.

Dr. Cashen has received numerous awards and held numerous medical staff positions and local/state committee posts. Her favorite awards include: the ACOS Resident Achievement Award, the Master Clinical Teaching Award from Ohio University College of Osteopathic Medicine, Preceptor of the Year award from LECOM, Ohio Osteopathic Association Trustee Award, and induction into the Mentor Hall of Fame of Ohio University Heritage College of Osteopathic Medicine.

Dr. Cashen considers one of her greatest academic achievements to be the seamless movement of her residency into full accreditation status with the ACGME. During the Single Accreditation process she has been an active member of the ACOS Residency Evaluation and Standards Committee. Most recently she represented formerly Osteopathic surgical residencies as a member of the Association of Program Directors in Surgery's focus group on the future of surgical education.

Dawn Tartaglione D.O., FACOS, grew up in northwest Missouri, adopted at birth by Ron and Peggy Wellington. She became the big sister to Christi, Rebecca, and Patrick. Her fondest memories of growing up are working on her grandparents' farm every Sunday after church during the summer. Her first exposure to osteopathic medicine was when she had a back injury at age 17 and her parents took her to an 88-year-old chiropractor. She thought he was amazing and when she said that she wanted to be a doctor and do what he was doing for people someday, he told her to read about osteopathy.



Dr. Tartaglione went to Truman State University in Kirksville, Missouri on a Pershing scholarship and graduated in 1990. She then worked for a year in Frederick, Maryland as a clinical scientist, where she was assigned to a laboratory at Fort Detrick. There she met and designed experiments with Wayne Mitchell, Ph.D. Dr. Mitchell had previously taught microbiology at the West Virginia School of Osteopathic Medicine and he encouraged her to stay on her path to become an osteopathic physician.

The Chicago College of Osteopathic Medicine (now Midwestern University) was her next stop and she completed her D.O. degree in 1995. Her neurosurgery residency took her to the Detroit, Michigan area and she completed her training through the Michigan State University Consortium in 2001.

Dr. Tartaglione became a Fellow of the ACOS in 2008 and began her service to the College as a Neurosurgery Discipline officer, joining the Board of Governors in 2010 as President of the Neurosurgery section. She was privileged to serve as Secretary-Treasurer for two years. Her service to the College continued when she was elected President of the ACOS, serving first as President-Elect followed by President for the 2015-2016 term. She was humbled to receive a Presidential Citation in 2018 from Dr. Ray Morrison for her tireless commitment to ACOS, and for promoting women

in medicine. She served as a Board Examiner for the American Osteopathic Board of Surgery from 2005 through 2011. She has also had the opportunity to teach as an Assistant Professor at Michigan State University, Philadelphia College of Osteopathic Medicine, and Drexel University.

LARRY G. ARMSTRONG, D.O., FACOS, FACS

ACOS President Larry G. Armstrong, D.O., FACOS, FACS is the Chief of Staff and Chair of Neurosurgery at Washington Regional Medical Center in Fayetteville, Arkansas.



Dr. Armstrong began his collegiate career studying Chemistry, Biochemistry, and Biology. After college, he worked as a chemical analyst for Mobil Oil Research and Development, The International Fertilizer Development Center, and Reynolds Aluminum. Feeling the need to pursue a medical career, Dr. Armstrong gave up his career in analytical chemistry and began working as a mechanic- taking classes to prepare for his medical school application. He began his medical school career at University of North Texas Health Science Center Texas College of Osteopathic Medicine in the fall of 1990, graduating in 1994.

Dr. Armstrong completed a Surgical Track Internship at Ohio University Doctors Hospital and Neurological Surgery Residency under the training of Program Director Gregory Z. Mavian, D.O., FACOS, finishing his residency in 2000. He also completed an 8-month Infolded Neurosurgical Spine Fellowship at The University of Arizona Health Science Center in Tucson in 1998. Dr. Armstrong received awards as a Neurosurgery Resident, including the prestigious Resident Achievement Award, First Place Neurosurgery Poster Award, and the Robert C. Erwin Literary Award.

Dr. Armstrong joined OrthoNeuro in Columbus, Ohio in 2000. From there, he relocated to Smith, Arkansas where he practiced with Cooper Clinic Neurosurgery. He moved his practice to Washington Regional Medical Center in 2004, where he has practiced for the last 15 years.

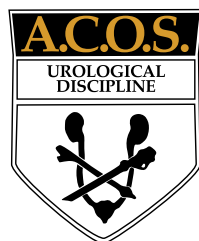
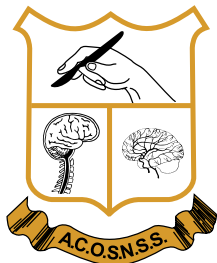

ACADEMIC REGALIA OF FELLOWS

The tradition, ceremony, and regalia used in the awarding of the title "Fellow in the American College of Osteopathic Surgeons" (FACOS) have their origin in the 11th and 12th centuries at European universities, where gowns distinguished academic doctors, masters, and bachelors from other segments of the population. Robes worn today have few modifications in design and still remain the sign of high office.

THE GOWN | The academic gown symbolizes the democracy of scholarship. It is usually black. The scarlet red used on the facing denotes God or "Great Physician" and blood, the life-giving fluid.

THE HOOD | The gold represents sunlight and distinguishes the surgeon as a student of the "Great Physician," always seeking light and knowledge in the care of the sick, afflicted, and infirm. The gold and black lining also represents the colors of the American College of Osteopathic Surgeons, the body conferring the award.

THE CAP | When Roman law freed the slave, he was granted the privilege of wearing a cap. The academic cap is a sign of freedom and responsibility of scholarship. The gold tassel signifies the doctorate degree.



SYMBOLS OF OFFICE

THE GAVEL | The presidential gavel, presented in 1958 by Mrs. Esther F. Martin, FACOS, in memory of her husband, Orel F. Martin, D.O., FACOS, a former College president and secretary, serves as a symbol of order, dignity, and progress.

THE GOLD-HEADED PRESIDENTIAL CANE | The cane, inscribed with the names of the College's presidents, serves as a symbol that the incoming president may lean on the experience and wisdom of those who have preceded him or her.
